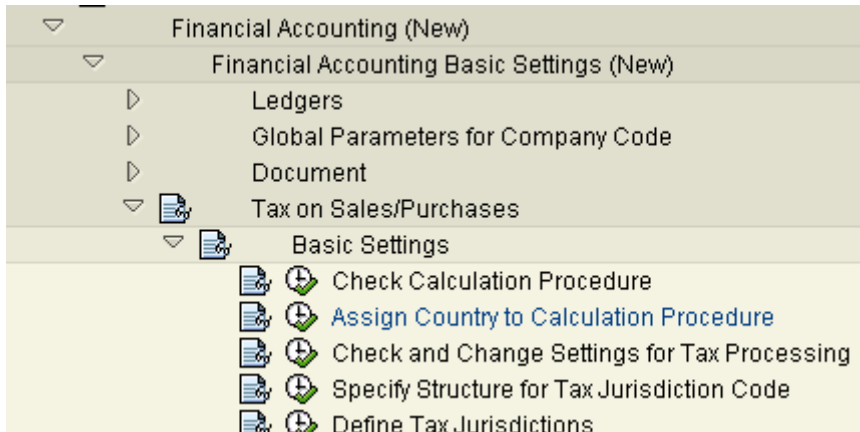


Tax calculation using Tax Jurisdiction code

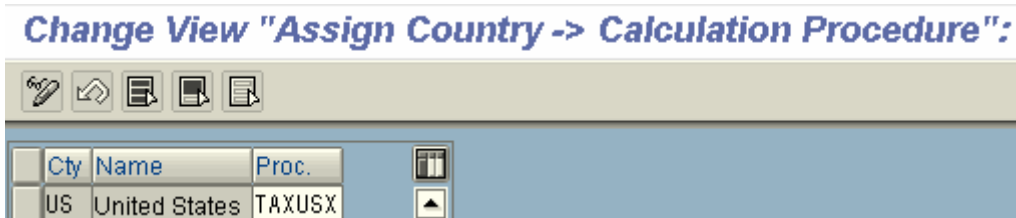

1. Tax calculation procedures for the country are maintained.

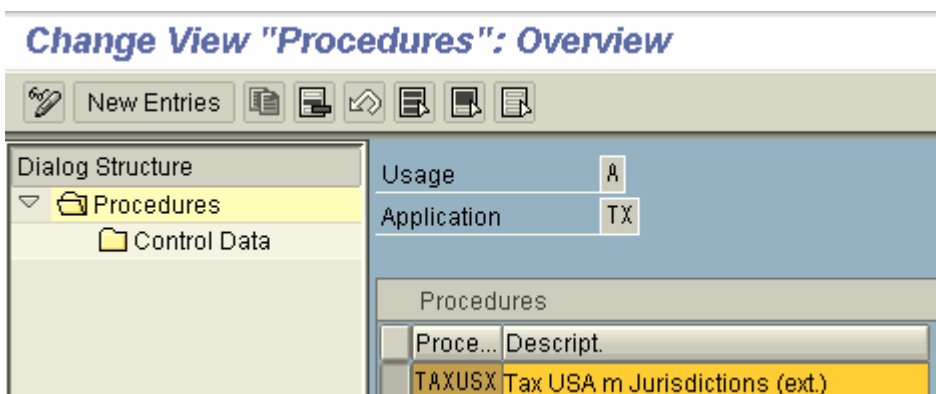


Click on “Assign country to calculation procedure”

On the next screen, select US



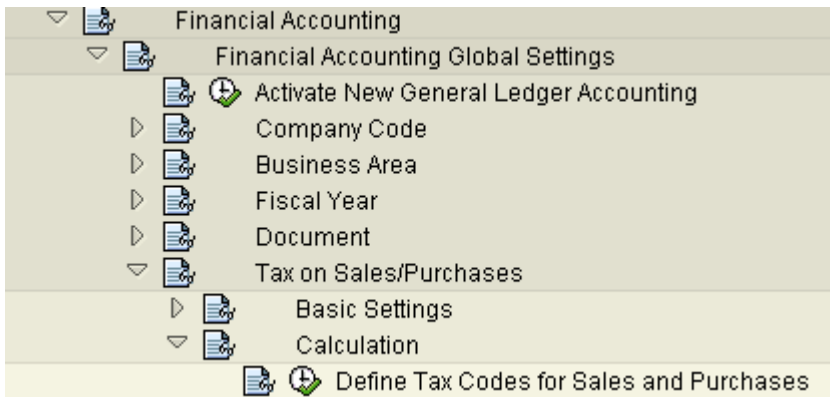
Click on “Check calculation procedure”



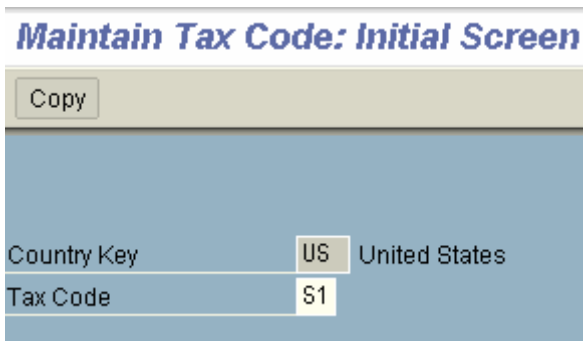
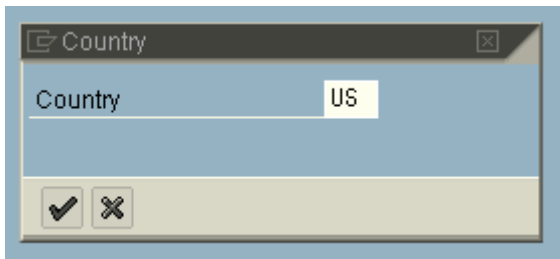
Procedure maintenance is part of FI. This will be then the tax procedure for US and tax rate calculation will be based on tax jurisdiction code (using external tax system like Vertex)
